### What information we collect, use, and why

# Lawful bases and data protection rights

### Our lawful bases for the collection and use of your data

Our lawful bases for collecting or using personal information to **provide services** and goods, including delivery and third party referrals are:

- Consent we have permission from you after we gave you all the relevant information. All of your data protection rights may apply, except the right to object. To be clear, you do have the right to withdraw your consent at any time.
- Legitimate interests we're collecting or using your information because it benefits you, our organisation or someone else, without causing an undue risk of harm to anyone. All of your data protection rights may apply, except the right to portability. Our legitimate interests are:
  - We have a legitimate interest in supporting you in attending an assessment and then enrolling in an English class, through advice or signposting. For example, if you include your mobile number when booking an assessment, we may call you regarding your assessment and to offer additional support and advice.

### How long we keep information

HubL securely retains user data for a period of three years to ensure the support provision language assessments and class enrolment.

#### Who we share information with

#### • Data processors:

- Website server hosting & database storage Hosting of website and assessment booking system, including a database of user bookings, English assessments, assessment results, and notes relating to the user's individual English language skills. This includes users' personal details provided at the time of booking, and is secured through restricted access and multi-step login verification.
- Email and cloud file storage Management of email and file storage systems, including all internal communications and storage of company files and records. This includes users' personal details provided at the time of booking, and is secured through restricted access and multi-step login verification.

#### • Others we share personal information with:

 Charities and voluntary organisations – we may share information regarding your English assessment outcome with local class providers to support and facilitate your enrolment.

## Sharing information outside the UK

Where necessary, our data processors may share personal information outside of the UK. When doing so, they comply with the UK GDPR, making sure appropriate safeguards are in place.
